Dear Mr. Walsh:

The Department of Transportation (Caltrans) received a bid submitted by Walsh Construction Company, Inc. (Walsh) for the above referenced Federal-Aid contract on March 12, 2024. By this letter, Caltrans notifies Walsh that its bid is nonresponsive.

Caltrans directs Walsh to Section 2-1.09 of the Special Provisions, which states, "The item total for plant establishment work must be at least \$104,000.00."

Caltrans finds that Walsh submitted its bid with the amount of \$48,730.96 listed for bid item 73, Plant Establishment Work. As such, Walsh failed to adhere to Special Provision 2-1.09, making its bid nonresponsive.

Based on the above, Caltrans will proceed to award the contract to the lowest responsive and responsible bidder, provided that all requirements are met.



