Dear Ms. Sewell,

Bay Cities was the second-lowest bidder for the Project. Bay Cities protests the bid of the apparent low bidder, Pacific Infrastructure Construction, LLC (Pacific) for failing to list the Public Work Registration Number for MJD Engineering as required by Caltrans Standard Specifications section 2-1.33B, Form Submittal Schedules.

Per the 2018 Standard Specification Section 2-1.03, no contractor or subcontractor may be listed on a bid proposal unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5. In its bid, Pacific listed MJD Engineering to perform Items 29 and 30. MJD Engineering is a corporation, Corporate Number C395712, listed with the California Secretary of State (Exhibit A). Per Standard Specification section 2-1.33B, Pacific was required to submit MJD Engineering's DIR registration number within "10 days after bid opening."

In its bid, Pacific listed MJD Engineering's DIR number as "100038364." As shown by the DIR's website, Registration number 100038364 (Exhibit B) is registered to "Mario Joseph de Sousa" who is a "Sole Proprietorship." The corporate entity of "MJD Engineering" was not registered with the DIR at the time of bid or within 10 days after the bid opening. Although Mario Joseph de Sousa (the president of MJD Engineering) has a DIR number for himself, the corporation of MJD Engineering never obtained a
