Dear Mr. Mauro:

The Department of Transportation (Caltrans) received a bid submitted by Shasta Services, Inc. DBA Timberworks (Timberworks), for the above project on May 23, 2024. By this letter, Caltrans notifies Timberworks that its bid is nonresponsive.

Caltrans refers Timberworks to the 2023 Standard Specifications, Section 2-1.15B, which states in part that for a Non-Federal-Aid Contract with a Disabled Veteran Business Enterprise (DVBE) goal: "Submit a copy of the quote from each DVBE listed on the Certified DVBE Summary form that describes the type and dollar amount of work shown on the form no later than 4 p.m. on the 4th business day after bid opening."

Caltrans confirms receipt of Timberworks' DVBE Submittal documentation on May 31, 2024 at approximately 11:31 a.m., which is after the submittal deadline of May 30, 2024. As a result, Timberworks' bid is nonresponsive.

Based on the above, Caltrans will proceed to award this contract to the lowest responsive and responsible bidder, provided that all the requirements have been met.


