Dear Ms. Conley:

The Department of Transportation (Caltrans) received a letter dated January 24, 2024, from Ghilotti Construction Company, Inc., protesting the bids submitted by Bay Cities Paving and Grading, Inc. (Bay Cities), Ghilotti Bros, Inc. (Ghilotti Bros), and Myers & Sons Construction Company, Inc. (Myers & Sons) for the above Federal-Aid referenced contract. The protest alleges that Bay Cities, Ghilotti Bros, and Myers & Sons are nonresponsive for failing to adhere to Section 2-1.09 of the Special Provisions that states, "The item total for plant establishment work must be at least \$110,000.00."

Caltrans need not comment on Ghilotti Construction's protest as Bay Cities, Ghilotti Bros, and Myers & Son are no longer eligible for award.

Based on the above, Caltrans will proceed to award the contract to the lowest responsive and responsible bidder, provided that all requirements are met.
