To Whom It May Concern:

With regard to the above-referenced contract, Papich Construction respectfully submits this request for correction of an inadvertent clerical error in the subcontractor listings for Bid Item 53 (Item Deleted Per Addendum) and Bid Item 78 (Class 2 Aggregate Base). In our bid submission, Papich inadvertently listed Greencoast Landscapes, Inc. for 100% of Bid Items 53 and 78.

A copy of Greencoast's proposal from bid day is attached and as can be seen, Greencoast did not quote the items in question. Additionally, we have notified Greencoast of the error and have included a signed statement from Greencoast acknowledging such and agreeing to release Bid Item 78 back to Papich. Since Bid Item 53 was deleted per an addendum, we have omitted it from the release as there is no work to be done.

Correction of such inadvertent errors is allowed by Public Contract Code Section 4107.5. As this contract bid on 5 December 2024 at 2:00pm, notice to the Department is due on 9 December 2024 by 2:00pm which this notice satisfies.

As such, Papich respectfully requests that the Department approve the joint request from Papich and Greencoast to correct the inadvertent listing in accordance with the provisions of PCC Section 4107.5.

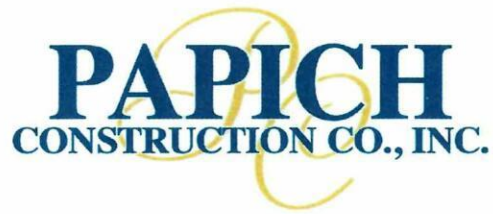

- Price based on one move-in. Any additional moves shall be billed at a minimum of \$3,250.00 each.
- All areas are to be received at +/- .10' of finish grade.
- Site to be received in a clean, weed free condition.
- If project is installed in phases or increments, the maintenance period for each phase/increment shall begin and end upon completion of that work portion, if any.
- Water meter must be available within 1/2 mile of project.
- All trees, pipe and wire shall be installed prior to new paving or hardscape. Protection of paving or hardscape by others.
- GreenCoast reserves the right to reject contract if base bid scope is not taken.
- Tree and tree roots to be removed prior to new paving and hardscape installation.
- GreenCoast will not begin any submittal process until a written contract or letter of intent has been received.
- All invoices to be paid net 30 upon invoice submission.

Exclusions-

- Subgrade grading, import/export of topsoils, compaction, backfill, waterproofing, electrical and telephone hookup/connections, electrical conduits, roadside clearing, trench plates, traffic control, traffic breaks, CHP, cozeep, permits, survey, notification, posting, audits, pot holing, bonds, reports, coring, boring, certified arborist, biologist, inspection fees, root chasing beyond four feet, root removal, flagging, tagging, marking, saw cutting, testing, any type of patching, s.w.p.p.p., hot tap, water costs, water meter connections, water meter and water permit.
