- 3. I was Granite's Estimating Assistant, assisting in the preparation of the Bid Form on Caltrans Contract 06-0Y1304, 06-Ker-33-40.4/59.3, Project ID0619000010 ("Project").
- 4. On May 23, 2024, bid day for this Project, Granite instructed me to populate the Subcontractor List and enter the intended subcontractor, Kellie Avila Construction Services, Inc. dba <u>Avila Traffic Safety</u>, as "Avila Traffic Safety" for Items 6, 7, 8, 9 on Page 11 of the Bid Form. However, I inadvertently and erroneously listed "Avila Traffic Control" as the traffic control subcontractor.
- 5. Based on the instructions I received during the preparation of the bid, and prior to the submission of the bid from Granite, it is my understanding that on bid day, Granite intended to list the traffic control subcontractor properly as "Avila Traffic Safety" on this Project.

Kellie Avila Construction Services, Inc. dba <u>Avila Traffic Safety</u> does not take issue with or object to Granite's claim of an inadvertent error on the Subcontractor List. Kellie Avila Construction Services, Inc. dba <u>Avila Traffic Safety</u> agrees that an inadvertent clerical error was made and accepts Granite's claim that "Avila Traffic Control" should be corrected to Avila Traffic Safety.


