Request for Bid Relief

Dear Office Engineer,

Thank you for the business opportunity to bid on this project. As directed by the Caltrans form DES-OE-041, this letter is being transmitted via fax within five (5) business days of the bid opening. WGJ Enterprises, Inc dba PCI submitted a bid (as posted by the State of California Department of Transportation ("Caltrans") via the Bid Express website) in the amount of \$1,368,093.40 for the above "referenced" contract on May 22nd 2024. Unfortunately, after review PCI has discovered a clerical error that occurred during bid submission that significantly altered our bid of what was otherwise intended and requests the withdraw of our bid submission pursuant to California Public Contract Code, section 5101 and 5103.

Item 27 (Preformed Thermoplastic Pavement Marking) was entered with a unit price of \$12.52 which is incorrect. The correct unit price shall have been entered at \$21.52 causing a large mathematical error in our bid. This mistake cost PCI an additional \$213,300.00.
